PROTECTIVE COVENANTS

TO WHOM IT MAY CONCERN:

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the undersigned is the owner of Lots 1 to 58, inclusive, in Cascio's Addition #2, a Subdivision, as surveyed, platted and recorded in Sarpy County, Nebraska.

NOW, THEREFORE, the following restrictions and protective covenants are hereby placed on the above mentioned lots, to-wit:

1. The covenants and restrictions herein set forth shall be binding upon 211 persons for a period of 25 years from and after date of recording of this instrument. At the expiration of said period, said covenants and restrictions shall automatically be extended for successive periods of ten (10) years unless they are changed in whole or in part by the vote of the majority of the owners

All lots herein described shall be known as and described as "Residential Lots," No structure shall be erected altered, placed or permitted to remain on any residential building altered, placed or permitted to remain on any residential building plot other than one (1) or two (2) story detached single family dwellings, with a private garage for not more than three (3) cars; with necessary out-buildings, and no lot or parcel therein shall be improved, used or occupied by other than private one family residence purposes and there shall not be erected, placed or maintained on any stations or any flats, duplexes; apartments, public garages, oil dwelling or any other buildings whatsoever, except single detached dwelling houses, to be used exclusively for one-family dwellings.

None of the said lots shall be re-subdivided into except.

3. None of the said lots shall be re-subdivided into ewo or more smaller lots. Nothing in this paragraph shall restrict any lots owner from conveying any part of his lot to an adjoining lot owner, provided however, that no lot, as a result of such sale, shall be reduced to an area of less than 10,000 square feet.

4. The ground floor area of the main structure, exclusive of one-story open perches and garages, shall not be less than 1,000 square feet in the case of a one-story home, or less than 900 square feet in the case of a two-story structure.

5. All buildings shall comply with the zoning regulations and building codes of the County of Sarpy, Nebraska, and in any nearer than thirty-five (35) feet to the front lot line, nor nearer than seven and one-half (72) feet to any side lot line, provided set-back requirements and side lot requirements as to any lot or lots in said addition are not adequate or satisfactory to the proper lots in said addition are not adequate or satisfactory to the proper development of said addition, the corporation, by resolution may alter or change the same, provided said change or alteration shall conform to and with the building permit issued by the County of Sarpy.

7. For a period of five (5) years from the date of the recording of this agreement no building shall be erected, constructed, altered, placed or permitted to remain on any lot in said addition herein described until the plans and specifications have been approved designated by said corporation.
